

**GENERAL
POWER OF ATTORNEY**

KNOW ALL MEN BY THESE PRESENTS, that I _____,

State of _____, by these presents do make, constitute and

State of _____, my true and lawful attorney, for me in my name,
place, and stead, and for my use and benefit.

SECOND: My attorney in fact shall have all lawful authority to act for me, including, but not limited to the following authority:

- a) To make, carry out, execute, bargain, deliver, agree for, sign, any and all contracts, applications, agreements, options, deeds, security agreements, leases, mortgages, covenants, assignments, bill of sale, conveyances, and documents of title;
- b) To make, sign, execute, endorse, acknowledge, deliver, receive, possess, any and all promissory notes, bills of exchange, insurance policies, annuities, bonds, debentures, bequests, legacies, checks, drafts, notes, stock certificates, trust deeds, warrants, certificates of deposit, commercial paper, receipts, and to withdraw, sign checks, deposit instruments, relating to any account or accounts, enter any safety deposit box leased in my name and remove any part or all contents thereof, in any bank, savings and loan or any other institutions or associations, and any other such instruments in writing of whatever kind necessary to exercise the rights and powers granted herein;
- c) To carry on, conduct, exercise, perform any act, right, power, duty, or obligation and conclude any and all negotiations in and about any business of mine within this state or elsewhere, to sign or endorse any and all stock certificates issued by a corporation or similar organization, to vote at any general or special meeting of stockholders all stock owned, held or controlled by me or standing in my name, to receive and receipt for dividends upon any stock belonging to me or standing in my name and on which I may be entitled to receive dividends, to sign, endorse, and execute bills of lading, warehouse receipts, bills of exchange, and proxies, and in every way deal in goods, wares, and merchandise and other property, and transact all and every kind of business of whatsoever nature as my attorney in fact shall deem proper;
- d) To collect, receive, demand, recover, sue for, all money, interest or moneys or credits, debts, belonging or owing to me on any account whatsoever, as are now or shall hereafter become due, and take all lawful means to collect, recover, or agree to discharges for the same;

e) To make, sign and execute in my name and on my behalf and all tax returns, local, State or Federal, which I may be authorized to make, and to receive, endorse, and collect checks payable to my order, drawn on the Treasurer of the United States, for whatever account, and give full discharge of the same;

f) To make, contract for, purchase, receive, insure, sell, improve, repair, maintain, manage, lease, take possession of all deeds, and in any manner deal with all or any part of my real property or whatsoever interest therein, which I own or acquire;

g) To compromise, perform any act, right, duty, power, or settle, or to sue and carry on any and all suits or legal proceedings of any kind, relating to any person, transaction, real property, personal property, or business property, for my benefit whatsoever;

THIRD: In addition, my attorney in fact has full power and authority to perform any and every act in the future in whatever nature and kind concerning my property and business the same or in relation thereto which I might personally do, hereby giving and granting unto my said attorney full power and authority to do and perform all and every act and thing whatsoever requisite or necessary or proper to be done in and about the premises as fully and to all intents and purposes as I might or could do if personally present with full power of substitution and revocation, hereby ratifying and confirming all that my said attorney may lawfully do or cause to be done by virtue hereof.

FOURTH: The enumeration of special powers herein shall in no way be construed to limit the broad general powers herein given, it being my intention, by this instrument to confer unto my said attorney in fact every power that may be conferred under the law of the land. This instrument is to be interpreted as a general power of attorney.

FIFTH: I hereby warrant, represent, and agree that:

a) No person or organization who relies upon this general power of attorney as representation of my attorney in fact shall incur any liability to me, my estate, my heirs, and successors for permitting my attorney in fact to exercise any power granted herein.

b) All third parties are hereby authorized to provide all information concerning my affairs to my attorney in fact without limitation and are released from any legal liability to me, my estate, my heirs, and successors for providing said information.

c) All third parties may accept the signature or acts of my attorney in fact granted in this general power of attorney as fully authorized by me with the same force as if I were personally present and acting on my own behalf.
